Sub: Passing of Resolution through Postal Ballot (Including E-Voting)

Dear Sir,

I, Mr. Ashok Kumar Daga, Membership No. FCS 2699 and COP No. 2948, Practicing Company Secretary, Kolkata was appointed as the Scrutinizer to receive, process and scrutinize the postal ballot (including evoting) in respect of the special resolution as circulated in the Postal Ballot Notice dated 09th January, 2015.

I hereby submit my report as under:

- The Company has engaged the services of NSDL for providing an electronic voting facility available to its shareholders, as an alternate to its members, instead of dispatching Postal Ballot Forms.
- 2. The Company has on Friday, 16th January, 2015, completed dispatch of Postal Ballot Notice pursuant to Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014 along with Postal Ballot Form and self-addressed Prepaid Business Reply Envelope to all the shareholders whose names appear in the Register of Members/Records of Depositories as on 09th January, 2015.
- 3. The Postal Ballot Voting (including e-voting) commenced from January 17, 2015 (00:00 hours) and ended on February 16, 2015 (17:00 hours).
- 4. Particulars of all Postal Ballot Forms received from the shareholders has been entered in a register separately maintained for this purpose.
- The Postal Ballot Forms were kept under my safe custody in sealed and tamper proof ballot boxes before commencing the scrutiny of such Postal Ballot Forms.
- All Postal Ballot Forms together with all votes cast by e-voting through NSDL received upto Monday, 16th February, 2015 (17:00 hours), being the last date fixed by the Company for receipt of the Postal Ballot Forms/E-Voting, were considered for my scrutiny.

7. The Ballot Boxes were opened on 16th, February, 2015 in the presence of two witnesses, who are not in the employment of the Company and whose signature is attested below:

- The details of e-voting facility provided by NSDL was scrutinized by me for verification of votes cast in favour and against the resolution.
- On scrutiny, I report that out of 7710 shareholders, 29 shareholders have exercised their vote through e-voting and 62 shareholders have exercised their votes through Postal Ballot Forms, as received. A summary of the result is given below:

Resolution No. 1: To change the name of the Company from KALPENA INDUSTRIES LIMITED to KKALPANA INDUSTRIES (INDIA) LIMITED, subject to approval of the Central Government.

"RESOLVED THAT pursuant to the provisions of Section 4(4), 13 and other applicable provisions, if any, of the Companies Act 2013, (including any statutory modification or re-enactment thereof, for the time being in force) read with Companies (Incorporation) Rules, 2014, and subject to such other consents, permissions and sanctions, as may be necessary, consent of the Members of the Company be and is hereby given for changing the name of the Company from KALPENA INDUSTRIES LIMITED to "KKALPANA INDUSTRIES (INDIA) LIMITED".

"RESOLVED FURTHER THAT the name of the Company KALPENA INDUSTRIES LIMITED, wherever it appears in the Memorandum and Articles of Association of the Company, be substituted by the new name, from the date it becomes legally effective."

"RESOLVED FURTHER THAT the Board of Directors of the Company be and is hereby authorized to do all such acts, deeds, matters and things as may be necessary, proper or expedient and to sign and execute all necessary documents, applications and returns for the purpose of giving effect to this resolution."
